REPLY OF COMMISSION STAFF TO PUGET SOUND ENERGY'S MOTION TO REOPEN DOCKETS AND AMEND ORDER

Puget Sound Energy, Inc. asks the Washington Utilities and Transportation

Commission to reopen consolidated Docket Nos. UE-040640 and UG-040641 and to amend

its Order No. 6 to clarify that the \$7 million cumulative annual threshold for catastrophic

storm damage will remain in effect until entry of a final order in the Company's next general

rate proceeding. The Company also commits to follow the reporting requirements set forth in

Order No. 6 and to address the threshold amount for catastrophic storm damage deferral in its

testimony in the upcoming general rate case.

Commission staff does not object to the Company's request. Staff also waives any opportunity for hearing that may be required by RCW 80.04.210 regarding amendment of a Commission order.
