NOTICE REVISING PROCEDURAL SCHEDULE

Re: *In the Matter of Pacific Power & Light Company, 2016 Power Cost Adjustment Mechanism, Docket UE-170717*

TO ALL PARTIES:

On June 1, 2017, Pacific Power & Light Company (Pacific Power or Company) submitted to the Washington Utilities and Transportation Commission (Commission) its 2016 Power Cost Adjustment Mechanism (PCAM) filing for approval. On October 2, 2017, both Commission staff and Boise White Paper, L.L.C. submitted letters to the Commission requesting that the matter be set for adjudicative proceeding.

On October 23, 2017, the Commission convened a prehearing conference in this docket and adopted an agreed procedural schedule. On October 26, 2017, the Commission entered Order 01; Prehearing Conference Order; Notice of Hearing, which established the procedural schedule, including an evidentiary hearing set for April 4, 2018.

On December 22, 2017, the Commission issued a Notice Revising Procedural Schedule and Notice of Hearing, which altered the procedural schedule and set the evidentiary hearing for May 1, 2018.

On March 8, 2018, Pacific Power filed a Motion to Amend the Procedural Schedule to allow all parties to be allowed to file supplemental testimony exhibits responsive to new information that Pacific Power provided on March 6, 2018, just two days before the March 8 deadline for cross-answering testimony and exhibits. Pacific Power states it has discussed the motion with the other parties and none object.

The Commission finds good cause to adjust the procedural schedule to allow parties to respond to the new information, without delaying the scheduled hearing. Therefore the procedural schedule is adjusted as follows:
