I apologize for the confusion. This is a reference that should have been removed from the final stipulation. As Ms. Cameron-Rulkowski pointed out earlier, the appendices were renumbered because we determined that Appendix C, which originally represented proposed tariff schedules was not necessary. As a result, what was Appendix D became Appendix C, and the proposed tariff schedules as Appendix C were eliminated. The reference to Appendix C in paragraph 30 should have been eliminated as well.
