

**FIRST AMENDMENT TO  
LOCAL INTERCONNECTION SERVICE AGREEMENT  
BETWEEN  
COMCAST PHONE, LLC AND COMCAST PHONE II, LLC  
AND COMCAST IP PHONE, LLC**

**THIS FIRST AMENDMENT TO THE LOCAL INTERCONNECTION SERVICES AGREEMENT** ("Amendment") is entered into as of the 1<sup>st</sup> day of February, 2009 ("Amendment Effective Date"), by and between Comcast Phone, LLC and Comcast Phone II, LLC, on behalf of its telephone operating subsidiaries ("Comcast") and Comcast IP Phone, LLC, on behalf of itself and its affiliates ("Customer").

**RECITALS**

**WHEREAS**, Comcast and Customer are Parties to a Local Interconnection Service Agreement ("Agreement") made as of May 15, 2008;

**WHEREAS**, Comcast has revised its rates for local interconnection service ("LIS") as of the Amendment Effective Date; and

**WHEREAS**, Customer has elected to amend the Agreement to accept the revised rates;

**AMENDMENT**

**NOW, THEREFORE**, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Agreement as follows:

1. Effective as of the Amendment Effective Date, the Agreement is amended as follows:
  - 1.1 The rates for LIS shall be set out in Attachment 1 to the Amendment.
  - 1.2 The LIS rates set forth in Section 1.1 shall replace the rates set forth in Exhibit B to the Agreement and shall be effective as of the Amendment Effective Date.
