ORDER GRANTING
APPLICATION

On September 4, 1991, Cascade Natural Gas Corporation (Cascade), a Washington corporation, filed an application to amend its present Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended, to include additional area in Kitsap County. (Appendix A-4)

Cascade is presently certificated for and is now providing gas service in Kitsap County. Cascade has requested to provide gas service to an area emidetially west of the city of Poulsbo, Washington. The additional area requested is contiguous to the aforesaid presently certificated area.

This Order makes no determination at this time as to the reasonableness of the gas pipeline facility construction to serve this addition to Cascade's service area, but reserves the right of the Commission to determine such reasonable services and expenditures, together with the treatment of same, in any formal proceeding before the Commission dealing with Cascade's results of operation for ratemaking purposes.

It appears the application herein should be granted to satisfy the public convenience and necessity.

FINDING OF FACT

1. Cascade Natural Gas Corporation, a Washington corporation, operates a gas plant for hire in this state and is subject to the jurisdiction of this Commission.
2. Cascade has heretofore been issued a Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended.
3. Cascade has filed an application to amend its Certificate of Public Convenience and Necessity, No, 4, amended, to include additional area contiguous to its presently certificated area in Kitsap County.
4. The operation of a gas plant for hire in the additional area requested is or will be required by the public convenience and necessity.
5. The Certificate of Public Convenience and Necessity to

Operate a Gas Plant for Hire, No. 4, amended, presently held by Cascade Natural Gas Corporation, should be further amended to include the additional area applied for herein.

ORDER

1. IT IS HEREBY ORDERED That the application of Cascade Natural Gas Corporation to amend its Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended, to include additional area contiguous to its presently certificated area in Kitsap County, is hereby approved and said Certificate shall be in accordance with attached Appendix A-4, which by this reference, is made a part hereof as though fully set forth herein.

2. IT IS FURTHER ORDERED That the Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended, issued pursuant to Order Paragraph No. 1, above, supersedes and cancels the Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, as amended and issued to Cascade Natural Gas Corporation on January 24, 1991 in Docket No. U-90082.

3. IT IS FURTHER ORDERED That the Certificate issued pursuant to Order Paragraph No. 1, above, is subject to the terms, conditions, and provisions of the Orders in Cause Nos. U-8841, U-8843, U-8937, U-9047, U-9052, U-9194, U-9238, U-9239, U-9253, U-9263, U-9264, U-9360, U-9388, U-9394, U-9407, U-9450, U-9467, U-9496, U-9600, U-9708, U-9759, U-9807, U-9808, U-9819, U-9790, U-9822, U-9860, U-9872, U-9873, U-9873, U-10001, U-74-19, U-78-50, U-80-06, U-80-22, U-80-100, U-81-43, U-83-40, U-83-40, U-83-41, U-84-55, U-85-04, U-85-76, U-900727 and UG-900782.


4. IT IS FURTHER ORDERED That jurisdiction over this order is retained to effectuate the provisions of this order.

APPENDIX A-4 AMENDED - LEGAL DESCRIPTION - BREMERTON, PORT ORCHARD
AND POULSBO AND VICINITY - KITSAP COUNTY

All of the incorporated area comprising the cities of Bremerton, Port Orchard and Poulsbo and additional portions of Kitsap County lying within the area described as follows:

Beginning at a point where the north line of Sec. 7, T. 26 N., R. 1 E.W.M., intersects the easterly meander line of Hood Canal; thence southerly to a point where said meander line intersects the west line of Sec. 12, T. 25 N., R. 1 W.; thence south along the west lines of Secs. 12, 13, 24, 25 and 36, T. 25 N., R. 1 W., and along the west lines of Secs. 1, 12, 13, 24 and 25, T. 24 N., R. 1 W., to the southwest corner of said Sec. 25; thence west along the north lines of Secs. 35 and 34, T. 24 N., R. 1 W., to the northwest corner of said Sec. 34; thence south along the west line of said Sec. 34, and along the west lines of Secs. 3, 10, 15, 22, 27 and 34, T. 23 N., R. 1 W., to the southwest corner of said Sec. 34; thence east along the south lines of Secs. 34, 35 and 36, T. 23 N., R. 1 W., and along the south lines of Secs. 31, 32, 33, 34, 35 and 36, T. 23 N., R. 1 E., and along the south lines of Secs. 31, 32, 33 and 34, T. 23 N., R. 2 E., to the intersection of the south line of said Sec. 34 with the meander line of Puget Sound; thence north along said meander line, and along the meander line of Sinclair Inlet, Port Orchard and Liberty Bay to a point where said meander line intersects the east line of Sec. 26, T. 26 N., R. 1 E.; thence north along the east lines of Secs. 26 to the south line of Sec. 24, T. 26 N., R. 1 E.; thence east along the south line of said Sec. 24 to its southeast corner of Sec. 24, T. 26 N., R. 1 E.; thence north along the east line of Secs. 24 and 13, T. 26 N., R. 1 E. to the northeast corner of said Sec 13; thence west along the north line of Sec. 13, T. 26 N., R.1 E. to the northwest corner of said Sec. 13; thence north along the east line of Sec. 11, T. 26 N., R.1 E. to the northeast corner of said Sec. 11; thence west along the north lines of Secs. 11, 10, 9, 8 and 7, T. 26 N., R. 1 E., to a point where the north line of said Sec. 7 intersects the easterly meander line of Hood Canal, the point of beginning.

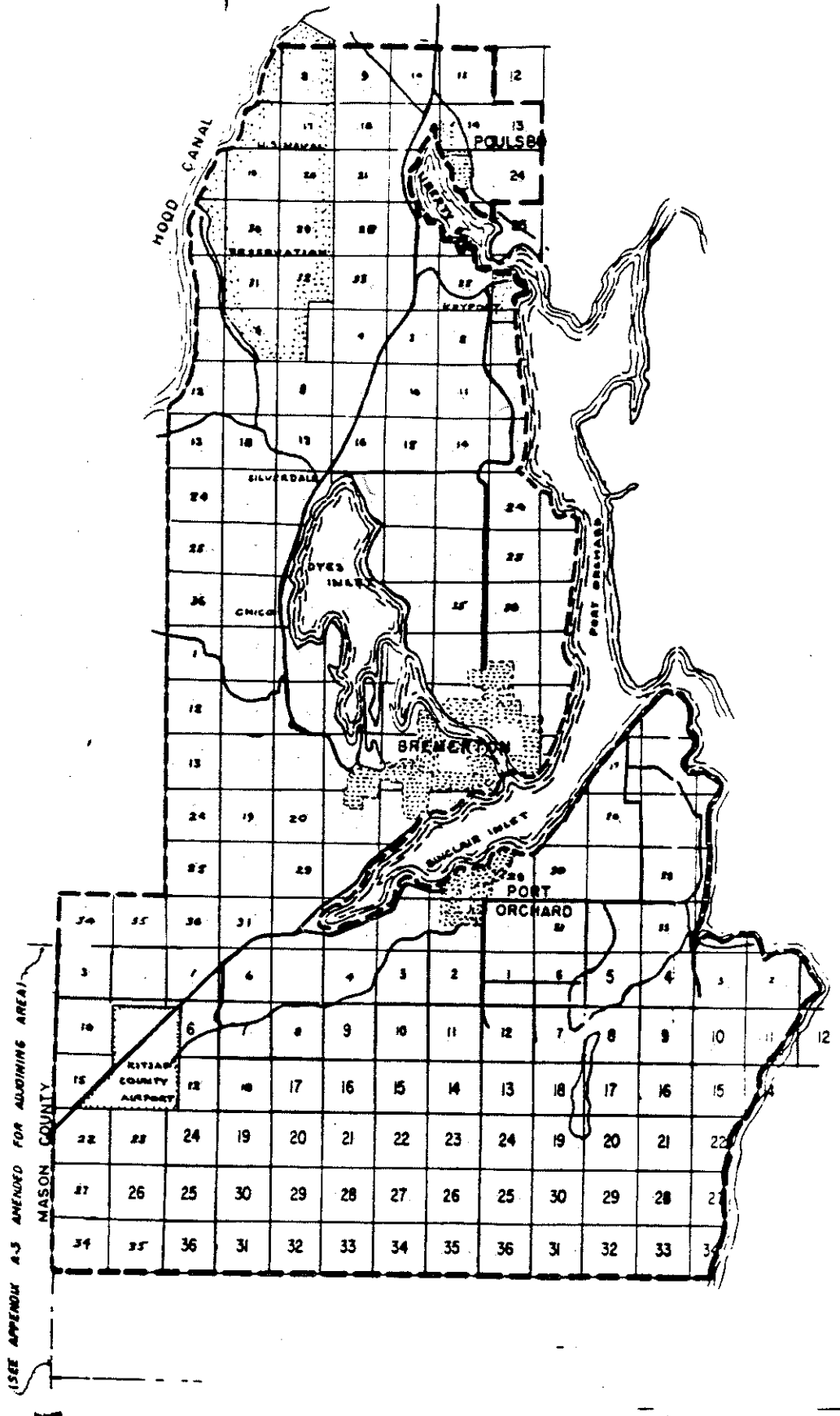
