Dear Executive Director Maxwell:

Microsoft Corporation files this letter in the above-referenced dockets to state its support for the Settlement Stipulation and Agreement on Revenue Requirement and All Other Issues Except Tacoma LNG and PSE's Green Direct Program ("Settlement"), and in particular Paragraph 45 of the Settlement. This paragraph fully and finally resolves Microsoft's obligation to contribute to decommissioning and remediation costs of Puget Sound Energy's interest in the Colstrip Generating Station. The basis for Microsoft's obligation, and the justification for Microsoft's payment as provided in the Settlement, is discussed in the Response Testimony of Irene Plenefisch, Exh. IP-1T. As the Settlement adopts Ms. Plenefisch's recommendation in her testimony as the resolution of this issue, Microsoft relies of this previously filed testimony as support for Paragraph 45 of the Settlement.
