NOTICE MODIFYING VIRTUAL SETTLEMENT HEARING
(Set for Monday, August 24, 2020 at 9:30 a.m.)

RE: *Washington Utilities and Transportation Commission v. PacifiCorp, d/b/a Pacific Power & Light Co.,*
Dockets UE-191024, UE-190750, UE-190929, UE-190981, UE-180778 (*Consolidated*)

TO ALL PARTIES:

On December 13, 2019, PacifiCorp, d/b/a Pacific Power & Light Company, (PacifiCorp or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective tariff, WN U-75 for Electric Service, designed to effect an increase in revenues of \$3.1 million from its Washington operations offset by the amortization of remaining deferred tax benefits associated with the Tax Cuts and Jobs Act of approximately \$7.1 million, resulting in an overall rate reduction of \$4 million, or approximately 1.1 percent. On January 9, 2020, the Commission suspended operation of the tariff revisions by Order 01, Complaint and Order Suspending Tariff Revisions.

On February 3, 2020, the Commission issued Order 03/01/06 that, among other things, consolidated Dockets UE-191024, UE-190750, UE-190929, UE-190981, and UE-180778 and established a procedural schedule, including an evidentiary hearing set for August 24-25, 2020.

On June 2, 2020, pursuant to a joint request made by the parties, the Commission issued a notice in these consolidated dockets suspending the procedural schedule, setting a deadline for the parties to file their settlement agreement and supporting documentation, and holding August 24, 2020, on the Commission's calendar for a possible settlement hearing.

On July 20, 2020, the parties filed with the Commission their settlement agreement and supporting documentation.

On July 22, 2020, the Commission issued a Notice of Virtual Settlement Hearing, requiring attendance online or by telephone using Skype for Business.

The Commission is transitioning to Microsoft Teams for virtual hearings. The Commission hereby gives notice that the Commission will conduct a virtual settlement hearing in these consolidated dockets using Microsoft Teams. The virtual hearing will be held on August 24, 2020, at 9:30 a.m., as previously scheduled. All parties and witnesses are required to appear using the Microsoft Teams web application.
