19 MR. ROBERTS: Okay. Thank you, Chairman

21 Good evening. My name is Andrew Roberts.
22 I'm public involvement representative with the Utilities
23 and Transportation Commission. I'm going to be
24 moderating the -- the comment hearing this evening.
25 I'd like to start with a little background
 information on the case. PacifiCorp filed a general

1 rate case to increase its rates and charges for electric
2 service effective January 1st, 2021. The settlement was
3 filed by UTC Staff and the Company on July 21st
4 proposing to increase annual electric revenues by 4.15
5 million or 1.18 percent, which includes crediting to
6 customers certain tax reform benefits.
7 This is a significant decrease compared to
8 the Company's original proposal. The Company originally
9 requested a 3.1 million revenue increase offset by the
10 return of 7.1 million in tax benefits, which would have
11 resulted a total revenue decrease of \$4 million.
12 Under the proposed agreement, a residential
13 electric customer would see a decrease of about .53
14 percent in 2021. Rates would then remain steady through
15 2023. An average residential customer using 1,200
16 kilowatt hours could see a decrease of about 55 cents a
17 month. The average monthly bill would be about \$103.81.
18 If approved, new rates would go into effect
19 January 1st, 2021.
20 You'll have the opportunity tonight to
21 provide your comments to the Commissioners pertaining to
22 the settlement details. The Commissioners act as judges
23 in formal filings like this and cannot answer questions.
