In compliance with Washington Administrative Code (WAC) 480-120-399 (2) I certify the following:

- A. Verizon Northwest Inc. (Verizon) provided the supported services required by 47 USC Section 214(e).
- B. Verizon advertised the availability of supported services and the charges for them.
- C. The funds Verizon received from the federal fund were used only for the provision, maintenance and upgrading for the facilities and services for which the support is intended.
- D. The 2003 annual amount of federal high cost universal service fund support received for Interstate Access Support was \$22,244,193.
- E. Verizon's federal high cost support was based on quarterly loop counts of 846,312, 845,238, 839,051 and 836,493.

In response to your May 13, 2005 memorandum, Verizon has also attached a copy of the advertisement placed by Verizon to meet its ETC obligations. I certify (or declare) under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct.

**PUBLIC NOTICE OF BASIC TELEPHONE SERVICES  
AVAILABLE FROM VERIZON**

Verizon is an Eligible Telecommunications Carrier (Eitel) in Washington State under the Federal Communications Commission (FCC) guidelines. Verizon is required to provide information about the basic services that we offer under those guidelines and depending on which telephone exchange you are served by, Verizon certifies that it provides the following basic services:

- Single-party service
- Voice-grade access to the public switched network
- Touch Call service
- Access to emergency services (including Enhanced 911)
- Access to operator, inter-exchange and directory assistance services

Rates for these services are as follows:

**Basic Residential Service:** \$9.68 plus per-minute usage charges for local calls.

**Premium Flat Rate Residential Service:** \$15.43 (includes unlimited local calling.)

**Basic Business Service:** \$20.13 plus per-minute usage charges for local calls.

**Premium Flat Rate Business Service:** \$32.13 (includes unlimited local calling.)

(Notes: Federal subscriber line charges are in addition to the rates discussed above.)

Verizon provides low-cost Lifeline service to qualified low-income residence customers at \$8.00 (flat-rate) a month including the credit for the federal subscriber line charges. Also available to Lifeline customers is low cost Link-Up basic connection service, which pays for up to one half of service installation non-recurring charges or \$30.00, whichever is less. Toll blocking is available to Lifeline customers at no charge. If Lifeline customers do not pay toll charges their access to the toll network may be denied but their local service won't be disconnected. Also, Lifeline customers are only eligible for PREMIUM FLAT RATE residential service.

Verizon also provides low-cost Lifeline service in its Native American Lifeline (NAL) program. Native Americans residing on federally recognized tribal lands who qualify for Lifeline may get their basic telephone service for \$1.00 per month. Native Americans residing on federally recognized tribal lands who meet the NAL eligibility criteria and are currently without phone service are also eligible for federal assistance of up to \$100.00 in Link-Up installation credits to establish telephone service.
