Dear Mr. Danner:

As mentioned in T-Mobile's Application for designation as an Eligible Telecommunications Carrier (the "Application") at page 7, T-Mobile's Lifeline offering includes (among other things) 145 Whenever® minutes, 500 night minutes, and 500 weekend minutes.

At the time that the Application was submitted, the per-minute overage rate for T-Mobile's Lifeline offering was \$0.40. In its response to the Commission Staff's Supplemental Information requests transmitted to the Commission on August 26, 2010, T-Mobile announced that it would be reducing the overage rate for its Lifeline offering from \$0.40 per minute to \$0.05 per minute by the end of 2010. T-Mobile has already reduced the overage rate for its Lifeline offering to \$0.05 per minute.

T-Mobile believes that this change makes it's already robust Lifeline offering competitive in today's market. T-Mobile notes that it has already received requests from Washington consumers for its Lifeline offering.

In light of this information, T-Mobile urges the Commission to consider and approve T-Mobile's application as soon as possible.
