Puget Sound Energy, Inc. (“PSE”) hereby submits in connection with Docket No. UE-132140, the following substitute tariff sheet replace and cancel the existing tariff sheets and to request withdrawal of all but one of the tariff sheets and attachments accompanying the Company’s November 20, 2013, filing which was submitted under the Company’s Advice No. 2013-30 and which was substituted on November 27, 2013, March 17, 2014, April 14, 2014, and September 2, 2014.

PSE has been diligently working with the assistance of Commission Staff to develop a new schedule (Schedule 152) that provides for interconnection with electric generators. The tariff provisions regarding interconnection were previously reflected in Schedule 80 and attachments but through the revision process involving Commission Staff those provisions are now reflected in Schedule 152 and attachments. This change in schedule number (from 80 to 152) required that changes be made to Schedules 150 and 151. PSE is submitting a separate tariff filing of Schedules 150, 151 and 152 coincident with this filing.

This substitution is provided for in WAC 480-80-111(a) which allows a substitution to address commission concerns with the filing. The tariff sheet described herein reflects the original issue date of November 20, 2013 and a revised effective date of October 3, 2014.
