GRANTING PAYMENT ARRANGEMENT

BACKGROUND

- On February 28, 2018, the Washington Utilities and Transportation Commission (Commission) issued a Notice of Intent to Cancel Operating Authority; Notice of Brief Adjudicative Proceeding; Setting Time for Oral Statements In the Matter of the Investigation of Keiko Martinez d/b/a U-Relax Moving and Delivery Service (U-Relax Moving and Delivery Service or Company) for Compliance with WAC 480-15 in Docket TV-180133. Also on February 28, 2018, the Commission assessed a penalty of \$8,300 in Docket TV-180132 against U-Relax Moving and Delivery Service for 87 violations of WAC 480-15.
- On March 15, 2018, U-Relax Moving and Delivery Service submitted a safety management plan that addressed each type of violation and the steps the Company has taken and will take to remedy those violations and ensure future compliance. Commission staff (Staff) examined the safety management plan and recommended the Commission consolidate the two dockets, upgrade the Company's safety rating to conditional, and assess a reduced penalty of \$4,150. Staff further recommended the Commission suspend a \$2,075 portion of the penalty for two years, and then waive it, subject to certain conditions. On April 9, Staff filed a letter informing the Commission that U-Relax Moving and Delivery Service accepted the conditions and waived its right to a hearing.

Pursuant to RCW 80.01.060(3) This packet is the final order In this docket.

- On April 10, 2018, the Commission issued a notice canceling the April 13, 2018, hearing, and on April 16, 2018, the Commission entered Order 01, which consolidated dockets TV-180132 and TV-180133, upgraded U-Relax Moving and Delivery Service's safety rating to conditional (allowing the Company to maintain its household goods carrier permit), and mitigated the assessed penalty to \$4,150. Order 01 also suspended a \$2,075 portion of the penalty subject to several conditions.
- On April 24, 2018, Staff contacted the Executive Director and Secretary of the Commission explaining that the Company requested to pay the penalty in installments, and that Staff supports the request. The Company and Staff jointly proposed the following payment schedule:

5 Staff also proposes that if U-Relax Moving and Delivery Service misses one payment, the entire balance will become due and payable immediately.

DISCUSSION

The Commission finds that the installment payment schedule Staff and the Company propose is reasonable. The Commission approves the proposal with three modifications. First, because the proposed September due date falls on a holiday, that due date is changed to September 4, 2018. Second, U-Relax Moving and Delivery Service may make additional payments in advance of the payment due dates or pay an increased amount on the due dates, but no additional payment or increased amount will relieve the Company of its obligation to make timely monthly installments until the full amount is satisfied. Finally, if U-Relax Moving and Delivery Service fails to pay the penalty by the date it becomes due in full – either immediately upon a missed installment, or April 1, 2019, whichever applies – the Commission may cancel the Company's household goods permit.

ORDER

THE COMMISSION ORDERS THAT:

- 7 (1) The \$2,075 penalty is due and payable to the Commission in installments according to the schedule set out in paragraph 4, above.
- 8 (2) If Keiko Martinez d/b/a U-Relax Moving and Delivery Service misses one payment, the entire balance will become due and payable immediately.
- 9 (3) Keiko Martinez d/b/a U-Relax Moving and Delivery Service may make additional payments in advance of the payment due dates or pay an increased amount on the due dates, but no additional payment or increased amount will relieve the Company of its obligation to make timely monthly installments until the full amount is satisfied.
