Escalating processing cost at the Waste Management processing facility over the past six months necessitates this filing.

**\* Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**

Sound Disposal, Inc. has incurred in-excess of \$30,000 unrecovered processing costs with processing costs increasing \$44.60 per ton between July 2022 and December 2022. The company has incurred increased processing costs of 35 percent between July 2022 and December 2022.

The company is requesting implementation of the revised rates on March 1, 2023
