I support and applaud Avista Corporation's request to implement an Electric Vehicle Supply Equipment Pilot Program to install Charging Stations on their customers' property in exchange for allowing Avista to collect data about their EV charging habits. It is clear that this program should be implemented. It presents a singular opportunity to the residents of Eastern Washington that has not been available to me here on the West side of the state. I still cannot easily get to the Ocean Beaches,

I have the happy experience of owning an all Electric Nissan LEAF. I waited from May 2010 to June of 2011 just to take delivery of one of the first 100 EV's delivered in State of Washington. I have driven approximately 47,000 miles without ever running out of power (Juice) or purchasing anything but electricity. On any trip longer than 65 or so miles I depend on DCFC (Direct Current Fast Charging) fuel stops. The 30 minutes it takes to charge allows me to stretch, get a hot drink and break up the trip. Charging at home while I sleep is "a no brainer" Ninety miles in three hours and I am set for my day. If I what to make a trip to my daughter's house in Spokane 295 miles it is a different story. I rent a "gasser", buy a Tesla, fly, or just wait until somebody put's in DCFC stations. Think how far you could go without "gas" stations! The only difference is our Plug in's just don't have as big a fuel storage at present. Every year we can go farther and farther as new models are offered. Ultimately, whatever we do we will have/need fueling stations. They will be DCFC stations, not on all four corners of an intersection that you frequently see but one Charging Station with multiple heads to handle multiple customers.

I support Avista's request with particular emphasis on the DCFC portion. It is an <u>essential</u> building block in the charging network. Without it an electric car is only a local commuter vehicle.

In a similar note, I am called a "first of". My first personal computer (Serial #5) was purchased before Microsoft was even in business in Bellevue/Redmond. (That computer and printer cost over \$33,000. My last one cost \$500.) I had one of the first "tell-a-copiers" now called a FAX machine. I had conference calling capability before they were commonly available. Owning an all electric car just seemed natural to me.
