As you may be aware, it has been nearly six years since our last general rate case. In that time, ED's Disposal, Inc. has experienced significant increases in costs that are essential to delivering services, including labor, fuel, maintenance expenses, along with federal and state employment taxes. In addition, the company continues to acquire new assets to ensure it can deliver the safest, most efficient and reliable service possible. If approved, the proposed rates will become effective on June 1, 2023.
