Advanced TelCom, Inc. dba Advanced TelCom Group (*ATG*) hereby respectfully requests that it be granted an extension to and including July 31, 2003 to comply with Order No. 6 in this docket as regards *ATG*'s review of information received from Qwest pursuant to that Order.

As grounds for this Motion, under Order No. 6, Qwest was required to provide certain information to *ATG* by July 18, 2003. Instead, Qwest did not deliver that information to *ATG* until 6:25 pm, substantially after regular business hours, on July 23, 2003. As a result, *ATG* actually received this information on the morning of July 24, 2003. See attached copy of email transmittal from Qwest, which is Exhibit A to this Motion. In a document sent as an attachment to that email, Qwest in effect admitted that its transmission of data to *ATG* was not timely under Order No. 6. A copy of that document is attached as Exhibit B. It would be manifestly unfair to have the burden of Qwest's failure to timely comply with this aspect of Order No. 6 fall on *ATG*. *ATG* will do its best to respond to the certification required by Order No. 6 as soon as possible. However, *ATG* respectfully requests that it receive the entire seven days contemplated by Order No. 6 for this response, should that be necessary.

WHEREFORE, Advanced TelCom, Inc. respectfully requests that it be granted an extension of time to and including July 31, 2003, within which to respond to the information provided to Advanced TelCom, Inc. by Qwest on July 24, 2003 under Order No. 6 in this docket.
