Paula M. Strain Statement of Qualifications

I am a 1977 graduate of the University of California, Berkeley, holding a Bachelor of Science degree in Business Administration with an emphasis in Accounting. I worked for a public accounting firm for four years and am a Certified Public Accountant, licensed in California, and a member of the AICPA. In 1981, I joined the staff of the Alaska Public Utilities Commission (now known as the Regulatory Commission of Alaska) and worked there as a financial analyst until 1992. While employed there, I participated as lead analyst in numerous rate cases, testifying on revenue requirement, cost of service, rate design, acquisitions and transfers, and cost of capital issues involving telephone, electric, water, sewer, oil pipeline, and cable television utilities, as contained in pages three to four of this exhibit.

I joined the Staff of the Washington Utilities and Transportation Commission in November 1992 and participated in telephone cases involving GTE Northwest Incorporated, the Washington Exchange Carriers Association and other telephone utilities. After one year working at the Washington Office of the Insurance Commissioner, I rejoined the staff of the UTC, again working in the telecommunications section. I testified in Docket UT-950200 (US West general rate case) on affiliated interest issues and the calculation of the directory yellow pages imputation; in Docket UT-960369 on avoided cost wholesale discounts; and in Docket UT-980948, US West's petition for an accounting order regarding yellow pages imputation.
