Beginning at the southeast corner of Sec. 31, T. 20 N., R. 29 E.; thence north along the east line of Sec. 31 and 30, T. 20 N., R. 29 E., to the northeasterly corner of said Sec. 30; thence west along the north line of said Sec. 30, and along the north line of Sec. 25, and 26, T. 20 N., R. 28 E., to the northwest corner of said Sec. 26; thence north along the east line of Sec. 22, T. 20 N., R. 28 E., to the northeasterly corner of said Sec. 22; thence west along the north line of Sec. 22, 21, and 20, T. 20 N., R. 28 E., to the northwest corner of said Sec. 20; thence south along the west line of Sec. 20, to the southwest corner of Sec. 20; thence west along the north line of Sec. 30, T 20 N., R. 28 E., to the northwest corner of said Sec. 30; thence south along the west line of Sec. 30 and 31, T. 20 N., R. 28 E., to a point where said line intersects the southerly shore line of Moses Lake; thence in a southeasterly direction along said shore line to a point where said line intersects the south line of Sec. 32, T. 20 N., R. 28 E., thence east along the south line of Sec. 32, 33, 34, 35, 36, T. 20 N., R. 28 E., and along the south line of Sec. 31, T 20 N., R. 29 E., to the southeast corner of said Sec. 31, the point of beginning.
