TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) will accept comments on NW Natural, d/b/a Northwest Natural Gas Company's (NW Natural or Company) final integrated resource plan for natural gas service. Per [WAC 480-90-238](#), an "integrated resource plan" (IRP or Plan) means a "plan describing the mix of natural gas supply and conservation designed to meet current and future energy demands at the lowest reasonable cost to the utility and its ratepayers." NW Natural filed its final IRP on September 23, 2022.

Per [WAC 480-90-238\(5\)](#), the Commission will hear comment on NW Natural's final IRP at an open public meeting. NW Natural representatives will present the final Plan to the Commission and respond to questions from the Commissioners and the public at a recessed open meeting of the Commission to be held on **Monday, February 27, 2023, at 9:30 a.m.**

The Commission will be holding the meeting virtually. Commission headquarters will not be open to the public for in-person participation. 
## WRITTEN COMMENTS
