# **SYNOPSIS**

*The Commission grants an Application for authority to transfer a portion of rights under one certificate of public convenience and necessity to another, and requires that the affected certificates be amended and reissued to reflect the transfer.* 

# **PROCEDURAL BACKGROUND**

- On October 16, 2002, Empire Disposal, Inc. ("Empire"), filed an application (No. GA-079113) for authority to transfer a portion of rights under Certificate No. G-37 standing in the name of Carroll-Naslund Disposal Service, Inc., d/b/a Naslund Disposal Service ("Naslund Disposal"), to Empire, holder of Certificate No. G-75 ("Application"). The Application was given number GA-079113 and notice of the Application was published in the Commission's weekly Docket of November 12, 2002.
- <sup>3</sup> The issues in this proceeding include whether the proposed transaction between Naslund Disposal and Empire complies with Washington state statute and rules and is otherwise consistent with the public interest. - A protest to the application was filed by Waste Management of Washington, Inc., but was withdrawn by letter filed January 31, 2003. On February 4, 2003, Empire filed a waiver of initial order in this proceeding, allowing the matter to proceed directly to a final Commission order based on a paper record. Commission Staff also consents to a waiver of initial order.
- <sup>5</sup> On February 26, 2003, Commission Staff responded to the application, stating that it had "no information to suggest that the requested transfer should not be granted." Staff recommended that the application be granted, and the affected certificates be amended and reissued to reflect transfer of the subject portion of authority from Naslund Disposal, G-37, to Empire, G-75.

# **FINDINGS OF FACT**

- 6 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington, vested by statute with authority to regulate rates, rules, regulations, practices, accounts, securities, and transfers of public service companies, including solid waste collection companies.
- 7 (2) Empire Disposal, Inc., has been serving the subject area for a significant period of time, and recently discovered that the area was within Naslund Disposal's service territory under Certificate G-37.
- 8 (3) Empire has reasonably considered the costs of providing service, those costs appear to be reasonable, and Empire possesses assets sufficient to begin and sustain operations for a reasonable period.
- 9 (4) Empire is fit, willing, and able to conduct operations under the requested transfer of a portion of Certificate G-37.

# **CONCLUSIONS OF LAW**

- (1) The Washington Utilities and Transportation Commission has jurisdiction over the subject matter of this proceeding and all parties to this proceeding.
- (2) The Application complies with Washington state statute and rules and is otherwise consistent with the public interest. The Application should be granted and the affected certificates should be amended and reissued to reflect the transfer of the subject portion of authority from Naslund Disposal, G-37, to Empire, G-75.

#### ORDER

# THE COMMISSION ORDERS That:

- (1) The Application for authority to transfer a portion of rights under Certificate No. G-37 standing in the name of Carroll-Naslund Disposal Service, Inc., d/b/a Naslund Disposal Service, to Certificate No. G-75 standing in the name of Empire Disposal, Inc., is granted.
- (2) Certificate No. G-75 standing in the name of Empire Disposal, Inc., is amended and will reissue per Attachment A to this Order.
- (3) Certificate No. G-37 standing in the name of Carroll-Naslund Disposal Service, Inc., d/b/a Naslund Disposal Service, is amended and will reissue per Attachment B to this Order.
