1 May 2, 2005, Commission Staff filed a complaint against Puget Sound Energy, Inc. (PSE). The complaint alleges that Pilchuck Contractors, Inc. (Pilchuck), a PSE contractor, failed to follow PSE Gas Operating Standards while performing work for PSE at 35th Avenue West and West Smith Road in Seattle. Because of the failure to follow PSE Gas Operating standards, an employee of Pilchuck was burned and hospitalized. A more detailed account of the dispute is reflected in the complaint, which is available for inspection at the Commission's office located at Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington, and on the Commission's web site at www.wutc.wa.gov/041209.

2 The Commission has jurisdiction over the subject matter of this Complaint pursuant to the provisions of chapters 80.01 RCW, 80.04 RCW, 80.28 RCW, chapter 480-93 WAC, chapter 480-07 WAC, and chapter 34.05 RCW. Specific provisions include but are not limited to: RCW 80.01.040, RCW 80.04.070, RCW 80.04.110, RCW 80.04.380, RCW 80.04.385, RCW 80.04.405, RCW 80.04.410, RCW 80.28.010, RCW 80.28.040, 80.28.130, RCW 80.28.207, RCW 80.28.210, RCW 80.28.212, and WAC 480-93-010, WAC 480-93-015, -080, -110, -183, -186, 187, -188.
