The company requests Commission approval to amend its filed Tariff Number 10 on Less than Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$1.9274 per gallon for the base period to \$2.5614 per gallon current price. Proposed changes are to add a Special Fuel Surcharge Supplement No. 11 in the amount of .88%.


For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of October 2009 and November 2009.
