RE: Prepaid Calling Services Disclosure Requirements – Rulemaking WAC 480-120-264, Docket UT-100148

TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in this rulemaking docket concerning possible adoption of proposed WAC 480-120-264, which contains regulations requiring the disclosure of information by prepaid calling service providers. This letter also provides notice of an opportunity to file written comments on the proposed rule amendments and to participate in the formal rule adoption hearing scheduled for 1:30 p.m. on Monday, June 28, 2010.

On April 5, 2010, the Washington Utilities and Transportation Commission (Commission) filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Code Reviser regarding disclosure requirements for prepaid calling services. The Commission developed the proposed rule revisions to WAC 480-120-264 with the benefit of stakeholder comments received on March 22, 2010, which are available in this docket on the Commission's website http://www.utc.wa.gov/100148.

The CR-102 begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
