
Description of amendment:

The Amendment provides specific terms under which Third Party Transit Provider exchanges traffic with CenturyLink as outlined in Attachment 1, Exhibit A, and Exhibit H to the Amendment.

The amendment amends the interconnection agreement first approved by the Commission on January 8, 2014 in WUTC Docket No. UT-133027 which approved the adoption of the Interconnection Agreement between Qwest Corporation dba CenturyLink QC and Sprint Communications Co. L.P. approved on February 11, 2004 under Docket No. UT-043002.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
