6 JUDGE CHARTOFF: Good morning. We are on 7 the record. Today is Monday, February 25th, 2019, and 8 the time is approximately 9:05 a.m. My name is Laura 9 Chartoff. I am an administrative law judge with the 10 Washington Utilities and Transportation Commission.

11 There are six household goods carriers who 12 should be here today. So the first thing I will do is 13 see who's here. There is a court reporter who is 14 recording everything we say, so when I call your name, 15 please raise your hand and say "here" or "present." And 16 if you are on the bridge line, just say -- identify 17 yourself.

18 So the first one is Docket TV-180519, Galaxy 19 Moving Company?

20 Okay. Hearing nothing, Docket TV-180798, 21 Pro Movers LLC, doing business as Groovin Movin?

22 Okay. Hearing nothing, Docket TV-190023, BM 23 Logistics LLC, doing business as Bogdan Movers?

24 MR. WALSH: Present with counsel.

25 JUDGE CHARTOFF: Thank you.

1 Okay. TV-180843, Stage 7 Movers?

2 MR. WILDES: This is Ken Wildes. I'm the 3 owner of Stage 7 Pianos.

4 JUDGE CHARTOFF: Thank you.

5 Okay. Docket TV-190020, Royal Moving?

6 MR. THEIS: Here.

7 JUDGE CHARTOFF: Thank you.

8 And Docket TV-190022, Mover For You?

9 MR. SACCHETTI: This is Mark Sacchetti, 10 owner/president of Mover For You LLC.

11 JUDGE CHARTOFF: Thank you.

12 Okay. So there are two companies who are 13 not here today. Those companies may be held in default. 14 I will deal with that later this morning.

15 Okay. So you are here because the 16 Commission has information that your company is or was 17 operating or advertising as a household goods carrier 18 without a permit. Operating as a household goods 19 carrier without the permit is illegal and subject to a 20 penalty of up to \$5,000 per violation.

21 If you are found to have engaged in business 22 as a household goods carrier without a permit, the 23 Commission can order you to cease and desist operating 24 and impose the penalty. The Commission has initiated 25 enforcement action against you and your business and at

1 this preliminary hearing, I am going to ask you how you  
 2 want to proceed.  
 3 So there are two options today. So option A  
 4 is to agree to cease and desist operating as an  
 5 unpermitted household goods carrier. If you choose this  
 6 option, you must agree to stop providing, offering, or  
 7 advertising unpermitted household goods services unless  
 8 or until you receive a household goods permit from the  
 9 Commission.  
 10 If you choose this option, you will need to  
 11 show what you have done to shut down your business  
 12 either completely or partially, and I'm going to want to  
 13 see proof that you're no longer operating or  
 14 advertising.  
 15 If you were operating without a permit but  
 16 have since applied for and obtained a permit in advance  
 17 of that hearing, please let me know when I call you up.  
 18 In that case, you can continue to operate so long as you  
 19 maintain your permit, but Staff will want you to agree  
 20 that you will stop operating if you lose that permit.  
 21 Okay. So that was option A. Option B is to  
 22 ask for a classification hearing, and you would choose  
 23 option B if you believe that you are not operating  
 24 illegally and that your business is not subject to  
 25 regulation from the Commission. In other words, you'd

1 be denying that you offer or advertised household goods  
 2 services.  
 3 So if you choose this option, we will  
 4 schedule a formal evidentiary hearing where you will be  
 5 required to present proof that your business is not  
 6 within the regulatory jurisdiction of the Commission.  
 7 And the hearing will be set in the next two months with  
 8 a deadline a week before the hearing for both you and  
 9 Commission Staff to list your witnesses and file any  
 10 exhibits. So I have some dates available. We'd be  
 11 looking at the end of March, beginning of April, or  
 12 possibly into May.  
 13 So Brian Braun will be speaking for  
 14 Commission Staff this morning. If you have not already  
 15 met Mr. Braun, he is seated at the table to my right.  
 16 He is a Commission compliance investigator.  
 17 So now that we've gone over your choices, I  
 18 will explain what else will happen this morning. So in  
 19 a few minutes, I will call you up here to make your  
 20 choice, and at that time, I will swear you in so that  
 21 anything you tell the Court will be under oath. And  
 22 once you're sworn in, I will ask if you understand your  
 23 choices for today's hearing and ask you to state your  
 24 choice. If there's anything else you want to explain to  
 25 me at this time, you will have a chance to do that.

1 And if you choose option A, that is to  
 2 testify how you're going to comply with the household  
 3 goods carrier laws and rules, whether by getting out of  
 4 the business or by maintaining your permit, you can  
 5 explain how you plan to do that. And depending on what  
 6 proof you can provide, you may be given an opportunity  
 7 to meet with Staff during the break to negotiate an  
 8 agreed order to resolve this matter. The agreed order  
 9 will also deal with the penalty.  
 10 So you were each served with a complaint  
 11 that asked the Commission to penalize you for engaging  
 12 in business as a household goods carrier without a  
 13 permit. The law sets the maximum penalty at \$5,000 per  
 14 violation. Staff will recommend a penalty, and you will  
 15 have a chance to reach agreement with Staff about the  
 16 penalty amount. If you're unable to agree, Staff will  
 17 explain the recommendation, but the Commission will make  
 18 the final decision about the penalty amount.  
 19 And finally, if you choose option B, that is  
 20 you're denying that you're operating as a household  
 21 goods mover, we will schedule another hearing. And in  
 22 that case, it would help if you know your schedule for  
 23 the next month or two so we can choose a hearing date.  
 24 So, Staff, I'll swear you in now.  
 25 (Brian Braun sworn.)

1 JUDGE CHARTOFF: Thank you.  
 2 Okay. And I'll call the carriers. I'll  
 3 start with BM Logistics LLC, Bogdan Movers. Please come  
 4 forward. So please make sure your microphone is turned  
 5 on and you probably have to pull it towards you.  
 6 MR. WALSH: We can share?  
 7 JUDGE CHARTOFF: Sure, sure. It's just so  
 8 people on the bridge line can hear what's going on.  
 9 Okay. So please -- so are you counsel?  
 10 MR. WALSH: Yes, I am. If I can introduce  
 11 myself? My name is Sean Walsh, counsel for BM Logistics  
 12 LLC. And on my right here is Orest Momotyuk. He is  
 13 vice president of BM Logistics.  
 14 JUDGE CHARTOFF: What was the first name?  
 15 MR. WALSH: Orest, O-r-e-s-t.  
 16 JUDGE CHARTOFF: Okay.  
 17 MR. WALSH: Momotyuk, M-o-m-o-t-y-u-k.  
 18 JUDGE CHARTOFF: Orest Momotyuk?  
 19 MR. MOMOTYUK: Correct.  
 20 JUDGE CHARTOFF: Okay. Thank you. So do  
 21 you understand the options that I presented this  
 22 morning?  
 23 MR. MOMOTYUK: Yes.  
 24 JUDGE CHARTOFF: And have you made a  
 25 decision?

1 MR. MOMOTYUK: Yes.  
 2 JUDGE CHARTOFF: Are you --  
 3 MR. WALSH: We're requesting a hearing.  
 4 JUDGE CHARTOFF: You're requesting a  
 5 hearing? Okay. Do you have your calendar with you?  
 6 MR. WALSH: I do.  
 7 JUDGE CHARTOFF: Okay. So I'm looking at --  
 8 I have the last week of March, the first week of April.  
 9 And should I read off the dates?  
 10 MR. WALSH: I have availability both those  
 11 weeks, but not every day.  
 12 JUDGE CHARTOFF: Oh, okay. I've got March  
 13 25th, 26th, 27th, or I've got April 1st through 4th.  
 14 MR. WALSH: The 27th is available.  
 15 JUDGE CHARTOFF: Does that work for Staff?  
 16 MR. BRAUN: Yes.  
 17 JUDGE CHARTOFF: Yeah? March 27th.  
 18 So can I ask why -- oh, you can bring the  
 19 microphone towards you. So your client is disputing  
 20 that they were operating or advertising?  
 21 MR. WALSH: That is correct. The business  
 22 was transferred to a different company that does have a  
 23 permit. It was in the process. The website is managed  
 24 by an individual in Philadelphia who had not updated the  
 25 website prop- -- fully. The business is now completely

1 transferred, but the website is now still down for  
 2 maintenance to make sure that it is in full compliance.  
 3 The company BM Logistics actually never  
 4 performed any moving services for anybody. They were  
 5 originally going to be merely a broker, brokerage-type  
 6 company where they connected to other moving companies.  
 7 And they -- the main business of Bogdan Delivery is  
 8 brokerage of long haul trucking. This was seen as a  
 9 side business that might allow people who have trucks  
 10 that aren't doing anything for the moment to do  
 11 something.  
 12 And in 2017, they decided to try this as an  
 13 alternative business model. They ran into this  
 14 particular issue back in October of 2017. They did  
 15 apply for the permit at that time, they looked at it  
 16 further, decided that this was not a lucrative business  
 17 model, and began the process of transferring the company  
 18 to another company.  
 19 JUDGE CHARTOFF: Oh, okay. And are you  
 20 aware of -- in Docket 170746, believe there's a -- there  
 21 was a prior cease and desist order?  
 22 MR. WALSH: Yes.  
 23 JUDGE CHARTOFF: And are you aware of  
 24 Staff's letter in that docket asking the Commission to  
 25 impose the suspended penalty?

1 MR. WALSH: Yes.  
 2 JUDGE CHARTOFF: Okay. Would you be --  
 3 would you want to consolidate those two matters --  
 4 MR. WALSH: Very much.  
 5 JUDGE CHARTOFF: -- for a hearing? Okay.  
 6 MR. WALSH: I haven't received an actual  
 7 order or anything from -- just that letter.  
 8 JUDGE CHARTOFF: Right. Yeah, the -- the  
 9 letter was sent, now it's pending Commission action.  
 10 Does Staff have anything they want to add?  
 11 MR. BRAUN: No, Your Honor.  
 12 JUDGE CHARTOFF: Oh, okay. So we will -- so  
 13 I'll set that hearing for 9:30 a.m. on March 27th, and  
 14 I'll get a notice out this afternoon or tomorrow. So  
 15 and if there's -- is there anything further?  
 16 MR. WALSH: I don't believe so.  
 17 JUDGE CHARTOFF: Oh, okay. So you are free  
 18 to go. Thank you for coming down.  
 19 Okay. Let's see, so I'm -- okay. So the --  
 20 next I'll call Docket TV-180843, Stage 7 Pianos.  
 21 MR. WILDES: Okay. I'm here.  
 22 JUDGE CHARTOFF: Still here, okay. So that  
 23 was -- can you repeat your first and last name and spell  
 24 your last name for the court reporter?  
 25 MR. WILDES: Kenneth Wildes, W-i-l-d-e-s.

1 JUDGE CHARTOFF: And what is your position  
 2 with the company?  
 3 MR. WILDES: I'm the owner.  
 4 JUDGE CHARTOFF: Okay. And I -- I  
 5 understand that you and Staff entered into an agreed  
 6 order; is that correct?  
 7 MR. WILDES: Yep.  
 8 JUDGE CHARTOFF: Okay. Staff -- oh,  
 9 Mr. Braun, do you want to bring me up a copy of the  
 10 order?  
 11 MR. BRAUN: Absolutely.  
 12 JUDGE CHARTOFF: So I'm going to go through  
 13 the order right now. So, Mr. Wildes, you had a chance  
 14 to review the whole order?  
 15 MR. WILDES: Yes, I did.  
 16 JUDGE CHARTOFF: And do you understand it?  
 17 MR. WILDES: I do understand it.  
 18 JUDGE CHARTOFF: Okay. And I see that you  
 19 and Mr. Braun have both signed it. Okay. It looks like  
 20 there's two violations in this case; one for offering a  
 21 move and one for advertising a move.  
 22 MR. WILDES: Yes.  
 23 JUDGE CHARTOFF: And a \$5,000 penalty is  
 24 imposed, a \$4,500 portion of the penalty is suspended  
 25 for a period of two years and then waived provided that

1 your company refrains permanently from further  
 2 operations as a household goods carrier without first  
 3 obtaining a permit.  
 4 MR. WILDES: Yes.  
 5 JUDGE CHARTOFF: Okay. And so the order to  
 6 cease and desist is permanent. It never expires. So if  
 7 Staff discovers you are still operating even after two  
 8 years, Staff can go straight to Superior Court and ask  
 9 for higher penalties. So do you understand that part?  
 10 MR. WILDES: Yes.  
 11 JUDGE CHARTOFF: Okay. So it's very  
 12 important that you follow the law. And let me see.  
 13 So is the entire part -- amount getting paid  
 14 today?  
 15 MR. BRAUN: I'm not for sure, Your Honor --  
 16 MR. WILDES: I --  
 17 MR. BRAUN: Go ahead.  
 18 MR. WILDES: So I believe that I'm -- I'm  
 19 expecting to pay \$500 today, and I -- I can do that.  
 20 JUDGE CHARTOFF: Okay. So do you have any  
 21 questions about the order, Mr. Wildes?  
 22 MR. WILDES: Nope. It's very clear about  
 23 it.  
 24 JUDGE CHARTOFF: Okay. I'll go ahead and  
 25 sign it. Mr. Wildes, do we have your permission to

 2 MR. WILDES: Yes, that's -- that's good.  
 3 JUDGE CHARTOFF: Okay. Mr. Braun, do we  
 4 have his email?  
 5 MR. BRAUN: I do, Your Honor.

 7 further?  
 8 MR. BRAUN: No, Your Honor.  
 9 JUDGE CHARTOFF: Okay. You're free to go,  
 10 and we'll get this order sent to you today. Thank you.  
 11 MR. WILDES: Thank you so much, Your Honor.  
 12 MR. BRAUN: Thanks.  
 13 JUDGE CHARTOFF: Okay. Okay. So next I'm  
 14 going to call Docket TV-190020, Royal Moving.  
 15 MR. THEIS: Hello, Your Honor.  
 16 JUDGE CHARTOFF: Good morning. Okay. Okay.  
 17 So can you please state your first and last name --  
 18 MR. THEIS: Yes.  
 19 JUDGE CHARTOFF: -- spelling your last name  
 20 for the record?  
 21 MR. THEIS: Jake --  
 22 JUDGE CHARTOFF: You can --  
 23 MR. THEIS: Jake --  
 24 JUDGE CHARTOFF: -- pull that closer to you.  
 25 MR. THEIS: All right. Jake Theis,

1 T-h-e-i-s, and I'm the owner.  
 2 JUDGE CHARTOFF: And do you understand the  
 3 options I laid out today?  
 4 MR. THEIS: Yes.  
 5 JUDGE CHARTOFF: Do you know how you want to  
 6 proceed?  
 7 MR. THEIS: Yes, option A. There was a --  
 8 just a little bit of com- -- miscommunication. I  
 9 actually purchased a new truck, and then on my old  
 10 truck, it cancelled out my permit. And I paid for my  
 11 new truck for the insurance for the year, and the  
 12 insurance company that I used, they go through another  
 13 insurance company. And they didn't send the information  
 14 over to UTC, which actually I was operating without the  
 15 permit at the time. But my insurance actually  
 16 reimbursed me the \$500 to reinstate the new permit, and  
 17 I was issued the new -- new permit last week. So I have  
 18 that here for my new permit as well.  
 19 JUDGE CHARTOFF: And in order to -- in TV --  
 20 there was a prior docket, TV-170972, in which you had a  
 21 suspended penalty; are you aware of that?  
 22 MR. THEIS: Correct. Well, that was because  
 23 I was operating with -- without the permit, but that was  
 24 due to the cancellation of my truck insurance. So  
 25 that's -- and the insurance company -- I mean, I paid

1 them all in full at once for the new truck insurance,  
 2 but they -- it's through TOP -- TOP Insurance and they  
 3 work through Columbia Insurance. Well, Columbia  
 4 Insurance didn't send that new information to the UTC.  
 5 So for those two months, I figured I had a  
 6 permit, but at the same time I didn't through UTC, but  
 7 because of miscommunication, the insurance was offering  
 8 the reimbursement of the \$500.  
 9 JUDGE CHARTOFF: Oh, okay. So are you aware  
 10 of Staff's letter seeking -- their letter dated February  
 11 7th seeking to impose that suspended penalty?  
 12 MR. THEIS: Yes, yeah.  
 13 JUDGE CHARTOFF: Okay. Is -- so I guess I  
 14 want to ask you and Mr. Braun if -- if you want to  
 15 discuss the other -- the suspended penalty as well and  
 16 deal with that today?  
 17 MR. THEIS: I thought -- I thought it was  
 18 all one -- one matter, that it was all one whole thing.  
 19 I spoke with Sue -- Suzanne Stillwell and Mike Dotson,  
 20 and they actually issued me the whole new permit because  
 21 it was all just a miscommunication through UTC and the  
 22 insurance.  
 23 JUDGE CHARTOFF: Okay.  
 24 MR. THEIS: I thought I complied with  
 25 everything I that needed to do. Every information that

1 I got, I either called UTC or the insurance, they told  
2 me what I needed to do, but it was kind of the middle  
3 insurance company that didn't send the information over  
4 in time. So but as of now, I do have the permit and  
5 everything's gone through so...

6 JUDGE CHARTOFF: Good. Good.

7 So, Mr. Braun, do you want to -- during the  
8 break, do you -- any objection to talking about the  
9 other penalty as well?

10 MR. BRAUN: No, Judge. We'll talk about it  
11 during the break.

12 JUDGE CHARTOFF: Okay. Okay. So yeah, when  
13 we take a break, you can talk to Staff and see if you  
14 can come to an agreed order.

15 MR. THEIS: Okay.

16 JUDGE CHARTOFF: And -- and once you feel  
17 comfortable that you understand the order and you agree  
18 with it, you and Mr. Braun will both sign it. It will  
19 likely include an agreed penalty amount, and if not, you  
20 can explain why the penalty should be different than  
21 what Staff is recommending.

22 MR. THEIS: Okay.

23 JUDGE CHARTOFF: Okay. Any questions?

24 MR. THEIS: Nope.

25 JUDGE CHARTOFF: Okay. So please return to

1 Okay. Can you start again, please? Are you still  
2 there?

3 MR. SACCHETTI: Is that any better?

4 JUDGE CHARTOFF: Yes, that's better. Thank  
5 you.

6 MR. SACCHETTI: Okay. Great, okay. Yes, I  
7 have -- I have stopped operating as a household goods  
8 carrier until I get my temporary license back, my  
9 temporary number back. I had applied back in August for  
10 my temporary number. I -- I thought all of my  
11 insurances were in place, and my insurance agent at the  
12 time did tell me that everything was compliant for  
13 Washington Utilities Commission for me to actually apply  
14 for a temporary number.

15 I did so. I was granted that temporary  
16 number and then received in October that it wasn't -- I  
17 did not have the proper coverages. So since then, I've  
18 been scrambling to get the proper cargo coverage that  
19 was stated. It was actually, the coverage was stated on  
20 my certificate of insurance, but for some reason, it --  
21 it wasn't applied to my policy. I -- I don't know why.

22 But anyway, I have gotten the proper  
23 coverages, and I just this morning re-sent everything  
24 with the application fee and everything to Michael  
25 Dotson to try to expedite this process after I take care

1 your seat, and you can speak to Mr. Braun at the break.

2 MR. THEIS: Thank you.

3 JUDGE CHARTOFF: Thank you.

4 Okay. So next I'm going to call Mover For  
5 You LLC, Docket TV-190022.

6 MR. SACCHETTI: This is Mark Sacchetti,  
7 president/owner of Mover For You. Last name is spelled  
8 S-a-c-c-h-e-t-t-i.

9 JUDGE CHARTOFF: Thank you. Oh, okay. I  
10 need to swear you in.

11 (Mark Sacchetti sworn.)

12 JUDGE CHARTOFF: Okay. Thank you. So,  
13 Mr. Sacchetti, do you understand your options here  
14 today?

15 MR. SACCHETTI: Yes, ma'am.

16 JUDGE CHARTOFF: And do you --

17 MR. SACCHETTI: Yes, I (inaudible) operating  
18 as a household goods carrier. I have reapplied for  
19 my --

20 JUDGE CHARTOFF: Hold on. Mr. Sacchetti, I  
21 can't hear you very well. Could you get a little closer  
22 to the phone?

23 MR. SACCHETTI: Is that better? Is that  
24 better? Is that any better?

25 JUDGE CHARTOFF: It's a little better.

1 of whatever fines, and whatever the situation I have  
2 with this, I'm hoping to be able to move forward after  
3 that.

4 So I'm not sure how to go from there. Like  
5 I spoke with Brian a little bit this morning about the  
6 situation. And like I said, I just wanted to be  
7 compliant. I'm just -- I thought I was and then I  
8 wasn't, and now that brings me to today's hearing. So  
9 but -- so that's where I am. So I think -- I think I  
10 want to go with option A until I can get the temporary  
11 permit again. It's -- that's not clear.

12 JUDGE CHARTOFF: Okay. Okay. So you would  
13 like to talk to Staff to see if you can come to an  
14 agreed order?

15 MR. SACCHETTI: Yes, ma'am.

16 JUDGE CHARTOFF: And is Staff okay with  
17 that?

18 MR. BRAUN: Yes, Your Honor.

19 JUDGE CHARTOFF: So I want to figure out how  
20 we're going to -- how you're going to connect with  
21 Mr. Sacchetti during the break. Do you have his phone  
22 number?

23 MR. BRAUN: I do. I have his cell phone.

24 JUDGE CHARTOFF: Okay. So is the plan that  
25 at some point in the next hour, I suppose, you're going

1 to give Mr. Sacchetti a call and see if you can  
 2 negotiate an agreed order?  
 3 MR. BRAUN: Correct.  
 4 JUDGE CHARTOFF: Okay. And, Mr. Sacchetti,  
 5 can you stay near your phone for the next -- at least  
 6 the next hour until Mr. Braun gives you a call?  
 7 MR. SACCHETTI: Yes, ma'am, absolutely.  
 8 JUDGE CHARTOFF: Okay. And then after --  
 9 after your negotiations with him, we're going to  
 10 reconvene this proceeding, and then you'll have to call  
 11 back in on the bridge line to participate in the -- in  
 12 the second half when we approve the orders if you're  
 13 able to come to one.  
 14 MR. SACCHETTI: Okay. One thing, will that  
 15 be today, will that be a later date?  
 16 JUDGE CHARTOFF: Yeah, yeah. So what  
 17 happens is after we take a break and Mr. Braun has a  
 18 chance to meet with the parties, we'll go back on the  
 19 record and I will approve -- I will go through and  
 20 approve the orders. So in --  
 21 MR. SACCHETTI: Okay.  
 22 JUDGE CHARTOFF: -- hopefully we'll get this  
 23 done quickly, but -- yeah, we'll -- we'll see how long  
 24 that takes, however long it takes. Okay. Do you have  
 25 any questions, Mr. Sacchetti?

 3 to recommend a penalty of \$5,000, with a portion of  
 4 \$4,000 suspended, with a thousand dollars due. Again,  
 5 the standard for this situation and for these  
 6 circumstances, and that's all we have to recommend.  
 7 JUDGE CHARTOFF: Okay. And the  
 8 circumstances are that he was previously permitted?  
 9 MR. BRAUN: Correct. That he was previously  
 10 permitted. During the time of not having a permit, I  
 11 was able to find advertisement and also to secure a  
 12 move. Yes, he has recently gained back his permit, but  
 13 during the time he did not have a permit, he operated.  
 14 JUDGE CHARTOFF: Okay. Okay. And,  
 15 Mr. Goncharuk, do you have anything else to add?  
 16 MR. GONCHARUK: I mean, to that, I  
 17 understand the Commission would like to serve its  
 18 penalty, they have a side. We have the judge in  
 19 between. And I mean, the only thing I've had is I kind  
 20 of already explained myself, and I'm at the mercy of the  
 21 advisement of the judge. So all I guess I have  
 22 commentary is if there's nothing -- better option for  
 23 me, I'd love to receive it. If not, then I appreciate

 25 the Commission to this point and waste their time being

1 default of \$5,000 penalty.  
 2 JUDGE CHARTOFF: Okay. So nothing would be  
 3 suspended?  
 4 MR. BRAUN: Correct.  
 5 JUDGE CHARTOFF: Please just briefly walk  
 6 through the evidence you have for this company as well  
 7 as when and how service was accomplished.  
 8 MR. BRAUN: On January 25th, 2018, I  
 9 reopened a 2017 investigation concerning Galaxy Moving  
 10 Company. On January 25th, 2018, I visited the website  
 11 of Galaxymoving.org. I observed a telephone number of  
 12 425-954-9276 advertising one truck and two movers for  
 13 \$85 an hour. I observed other observations of  
 14 advertisements on Yelp, and when I looked up at the  
 15 Secretary of State for Galaxy Moving, I found the  
 16 information of an individual of a Hong Brooks.  
 17 On January 30th, 2018, I searched Commission  
 18 records and verified that Galaxy Moving was not  
 19 permitted. And also on January 30th, 2018, I sent a  
 20 compliance letter to Hong Brooks of Galaxy Moving asking  
 21 them to cease and desist or become compliant. On  
 22 March 6th, 2018, I sent another compliance letter  
 23 notifying them to cease and desist operations.  
 24 On April 23rd, 2018, posing as a customer, I  
 25 called the same phone number as before, I spoke with an

1 individual who identified himself as Rick and stated  
2 that he was the owner of Galaxy Moving. I received a  
3 quote of \$80 per hour for two guys and a truck or \$120  
4 per hour for three guys and a truck to move between two  
5 points in Washington State.

6 After all the orders were submitted,  
7 Mr. Brooks was -- tried to avoid service, was actually  
8 served on January 21st of 2019 at 12306 - 19th Avenue  
9 Southeast in Everett. With that order to the process  
10 server, I included a photograph. Mr. Brooks stated that  
11 he wasn't who he was but was able to confirm to the  
12 photo identification.

13 To appear -- as the Court is aware, the  
14 scheduled hearing was for February 12th, 2019. That  
15 hearing was postponed due to weather inclement. I  
16 called Mr. Brooks and was asking, said, hey, as a  
17 courtesy, could you please -- you know, can I have the  
18 email address so that I can send you the notice because  
19 we're getting -- we're having these adjournments.  
20 Mr. Brooks was adversarial. Mr. Brooks responded to me  
21 as, You have my email address, you know the website,  
22 just send it there.

23 And so he was aware of the new pending court  
24 date of today with proper service, and I ask for the  
25 default.
