GRANTING APPLICATION

BACKGROUND

- 1 On May 24, 2021, Howling Moon Shuttle, LLC, d/b/a Howling Moon Shuttle, filed with the Washington Utilities and Transportation Commission (Commission) an application requesting a certificate of public convenience and necessity to provide the following service:

DOOR-TO-DOOR PASSENGER SERVICE:

By reservation only within the townships and surrounding areas of Cle Elum, Roslyn, Ronald, Suncadia and South Cle Elum.

All passengers must originate or terminate in one of the townships and surrounding areas of Cle Elum, Roslyn, Ronald, Suncadia and South Cle Elum.

Charter and Excursion Carrier Services in the state of Washington.

- 2 The application appeared on the June 4, 2021, application docket. The application was unopposed.
- 3 After reviewing the application, Commission Staff (Staff) determined that the application complies with the Commission's requirements for an auto transportation authority and recommends that the Commission grant the Company's application.

DISCUSSION AND DECISION

4 The Commission, having considered the application and being fully advised, finds that the
Company is fit, willing, and able to provide the proposed extended service and that the proposed
service extension is necessary and will be a convenience to the public.

ORDER

THE COMMISSION ORDERS:

- 5 (1) The application for a certificate of public convenience and necessity filed by the Company
in this docket is granted. The Company's certificate C069777 is provided in Appendix A
to this order.
- 6 (2) The tariff and time schedule for the Company filed in connection with this application will
become effective at 12:01 a.m. on the day following the service date of this Order.
- 7 The Commission has delegated authority to the Secretary to enter this Order under RCW
80.01.030 and WAC 480-07-905(6)(c).
