RATE INCREASE NOTICE FOR MEDICAL WASTE

Dear Customer:

February 28, 2023

Murrey's Disposal Co., Inc. has filed a request for a medical waste rate increase with the Washington Utilities and Transportation Commission (UTC). The last medical waste general rate increase was approved by the UTC September 1, 2019. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, and general operating costs.

If approved, the proposed rates below will become effective April 1, 2023.

| 401-500 | \$0.95 | \$0.19 | \$1.14 |
| 500+ | \$0.89 | \$0.18 | \$1.07 |
| Minimum Monthly Charge | \$15.00 | \$2.96 | \$17.96 |

Other medical waste services not listed will increase an average of 19.73%

If you have any questions regarding this increase, please contact Murrey's Disposal Co., Inc. between 8 a.m. and 5 p.m. Monday through Friday.

The UTC has the authority to set final rates that may be either lower or higher from the company's request, depending on the results of its investigation. UTC staff will make a recommendation to the Commissioners at an open meeting which is scheduled for 9:30 a.m. on Thursday, March 23, 2023. This open meeting will be conducted remotely.
