## RATE INCREASE NOTICE FOR COMMERCIAL CONTAINER AND CAN SERVICES

Dear Customer:

August 15, 2023

Yakima Waste Systems, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (UTC). The last general rate increase was approved by the UTC August 1, 2022. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets.

If approved, the proposed rates below will become effective October 1, 2023. The rates will increase as follows:

You will have an opportunity to provide your comments at this meeting either in person or remotely.
