GRANTING APPLICATION

BACKGROUND

1 On August 17, 2023, HHR Shuttle Service LLC, filed with the Washington Utilities and Transportation Commission (Commission) an application requesting a certificate of public convenience and necessity to provide the following service:

SCHEDULED NONSTOP PASSENGER SERVICE BY RESERVATION ONLY
BETWEEN Yakima and the Tri-Cities Airport. Pickup/drop off from 2 E Valley Mall
Blvd, Union Gap and the Tri-Cities Airport via Interstate 82.

2 The application appeared on the August 17, 2023, application docket. The application was not protested.

3 After reviewing the application, Commission Staff (Staff) determined that the application complies with the Commission's requirements for an auto transportation authority and recommends that the Commission grant the Company's application.

DISCUSSION AND DECISION

4 The Commission, having considered the application and being fully advised, finds that the Company is fit, willing, and able to provide the proposed extended service and that the proposed service extension is necessary and will be a convenience to the public.

ORDER

THE COMMISSION ORDERS:

- 5 (1) The application for a certificate of public convenience and necessity filed by the Company in this docket is granted. The Company's certificate C070993 is provided in Appendix A to this order.
- 6 (2) The tariff and time schedule for the Company filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this Order.
- 7 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-905(6)(c).
