The Company has not reviewed or verified Washington Utilities and Transportation Commission (WUTC) staff's analysis provided in the confidential table to this data request. However, the Company provides the following readily additional information:

For "QF Washington" – please refer to Confidential Attachment WUTC 27 which provides actual hourly data for the Washington qualifying facilities (QF), namely Yakima Tieton Cowiche and Yakima Tieton Orchard. This information was inadvertently missing from the Company's response to WUTC Data Request 16.

For "Mid-Columbia Contracts" and "STF Purchases" – please refer to the Company's response to WUTC Data Request 25.

For "Colstrip", "Jim Bridger", "Chehalis" and "Hermiston" – please refer to the Company's response to AWEC Data Request 016, specifically Confidential Attachment AWEC 016-2, confidential folder "23-035-01 CONF Attach EBA FR 6-8 RMP" which provides actual hourly generation logs for the Company's owned or co-owned resources – including hourly generation data for Colstrip, Jim Bridger, Chehalis and Hermiston.
