Pacific Power currently offers a variety of options to help you save energy and money. Rebates and incentives are available for replacing worn irrigation equipment and for installing variable frequency drives on pumps. If you sign up for paperless billing, you will receive a \$0.50 bill credit each month, and if you add Auto Pay, you can earn an additional \$1 monthly bill credit. Together these credits equal \$18 annually. For more information, visit **pacificpower.net/billoptions**.

## KEEPING YOU INFORMED PROPOSED RATE CHANGE

In 2016, the Washington Utilities and Transportation Commission approved a decoupling mechanism that requires Pacific Power track and defer the difference between allowed revenue and actual revenue and file true-up adjustments by December 1 of every year.

Last year, the Commission approved a 0.315 cents per kilowatt-hour surcredit for irrigation customers, which will expire on January 31, 2022. The expiration of this surcredit will result in a 3.4 percent price increase for irrigation customers. A typical irrigation customer using 30 megawatt-hours annually will see an annual bill increase of \$94.50, spread over their monthly bills.

The Commission will examine Pacific Power's filing and may determine that the filing be accepted as filed, modified, or rejected. If accepted as filed, the price change would go into effect February 1, 2022.

The Commission has the authority to set final rates that may be lower or higher than the company's filing. You are invited to comment to the Commission using the "Submit a Comment" feature on the Commission's website at utc. wa.gov, or by using the following contact information.
