

#### **Overview**

The Washington State Department of Ecology (Ecology) provides grants to local governments to investigate and clean up contaminated sites. Many of the grants require that local governments provide a 50% match to these funds. However, if an applicant is "economically disadvantaged," Oversight Grants and Independent Remedial Action Grants may be funded up to 75% of the eligible project costs.

A city, town, or county is economically disadvantaged if its per capita income is equal to or below the median per capita income for that location as determined on July 1st of each odd numbered year, based on the latest official American Community Survey five-year estimates of the U.S. Department of Commerce (WAC <u>173-322A-100</u>(15) and (16)).<sup>2</sup>

The tables in this document identify which counties, cities, and towns are economically disadvantaged and eligible for a reduced match for grants they receive between July 1, 2021, through June 30, 2023.

## **Economically Disadvantaged Counties**

As of July 1, 2021, the median annual per capita income for counties in Washington state was \$29,695.

Counties listed in Table 1 are at or below the median income. These counties are considered economically disadvantaged for the purposes of Remedial Action grant funding and qualify for reduced local match.
