This email is to notify you and the Washington Utilities and Transportation Commission (Commission) pursuant to WAC 480-07-730(4) that a settlement in principle has been reached in this proceeding. Although the Public Counsel Unit of the Attorney General's Office (Public Counsel) did not file testimony in this proceeding, Public Counsel participated in settlement negotiations and will indicate its position on the settlement by the end of the week.

Pursuant to WAC 480-07-385(2)(b), Commission Staff requests that the Commission suspend the procedural schedule in this docket. All of the parties to this proceeding support this request.
