Net metering is a program structure for customer generators where the energy they export to the grid is subtracted from the energy delivered to them from the grid and the customer generator is billed for the net quantity of energy at standard retail tariff rates.

Net billing is a program structure for customer generators where they are billed for the energy delivered to them from the grid at standard retail tariff rates and are credited financially for the energy they export to the grid at the net billing program rates.
