TO ARIZONA TAG MEMBERS

Attached are redlined and non-redlined copies of Qwest's proposed revised changes to the PO-16 update proposed in response to TAG questions. This also incorporates the additions of new items as Qwest agreed previously (i.e., OSS Retirement Notices and Introduction Notices for new OSS systems.

As to the questions about the previously-proposed last bullet in the description section, dealing with the "RN" designation, Qwest is proposing to remove that bullet and, instead, align the descriptions of the notifications exactly with the descriptions in the CMP document that governs such releases and their timeframes. Thus, rather than using an "RN" designator, which could be a potential point of future error in applying it, notices can be identified as qualifying for this measurement by their title and by the systems they cover, as specified in this PID and in referenced CMP documents. As a result, also, several of the Notes recently added are no longer needed and are removed in this draft.

Qwest proposes the TAG consider this PID for approval in the 21 May 02 TAG meeting.
