The purpose of this filing is to comply with the portion of the Commission's Order No. 08, Rejecting Tariff Sheets; Authorizing and Requiring Compliance Filing, in consolidated Docket Nos. UE-111048 and UG-111049 (the "Order") that address natural gas rates. Puget Sound Energy Inc. ("PSE" or the "Company") is submitting a separate filing of its electric tariff sheets in compliance with the Order under the Company's advice number 2012-10. The attached revised natural gas tariff sheets reflect the form and rates authorized in the Order.

As required by WAC 480-07-883(2) a copy of this filing has been served on each party to this proceeding.

The enclosed revised tariff sheets reflect issue dates of May 9, 2012, and effective dates of May 14, 2012 by authority of the Washington Utilities and Transportation Commission in Docket Nos. UE-111048 and UG-111049 (Consolidated). Work papers that demonstrate the derivation of the rates proposed to be changed by the enclosed tariff sheets are attached herewith in electronic format. In accordance with the Order, the enclosed natural gas tariff filing is based on a revenue deficiency of \$13,389,128 or an overall increase in natural gas rates of 1.3% over rates in effect at the time Docket Nos. UE-111048 and UG-111049 were filed with the Commission.
