Following the stakeholder workshop held on August 12, 2003, Commission Staff has completed a second discussion draft of WAC 480-62-320 Remote Controlled Operations. In developing this draft, Staff considered the written comments submitted by interested persons, as well as the oral comments from the stakeholder workshop held on March 19, 2003, and August 12, 2003. The draft rules are available for inspection on the Commission's web site at www.wutc.wa.gov/021465. The Commission will send a paper copy of the draft rules or will send the proposal via electronic mail, if requested.

In this second discussion draft, Staff has modified the discussion draft prepared and made available on the website in June 2003. Staff has made the following changes to the June 2003 discussion draft:

- Added definitions of "remote control area" and "remote control zone" based upon language in railroad general codes of operation;
- Modified reporting requirements for remote control areas and remote control zones

operating in the state by requiring 60 days notification of intent to begin operations, and streamlining the information that must be reported;

- Removed a draft rule requiring installation of signs prior to initiating remote controlled operations;
- Removed a draft rule requiring construction of physical barriers prior to implementation of a remote control zone;
- Modified the wording of draft rules addressing point protection at crossings and where trains can enter main line track.
- Included a draft rule providing for Commission staff initiation of periodic workshops concerning the safety of remote-control areas or zones, including representatives of the railroad, railroad employees, governmental representatives, union members, and other persons affected by remote-controlled operations.
