TO ALL PARTIES OF RECORD:

On August 28, 2002, the Commission entered its Thirteenth Supplemental Order: Rejecting Tariff Filing; Approving and Adopting Settlement Stipulation; Authorizing and Requiring Compliance Filing in Docket Nos. UE-011570/UG-011571, and Order Approving Purchased Gas Adjustment on Less Than Statutory Notice in Docket No. UG-021059, ("Joint Order")<sup>1</sup>.

On August 30, 2002, parties to these proceedings filed, pursuant to WAC 480-09-815(2), a request to correct obvious ministerial errors that appeared in the Joint Order.

The parties represent that none of the proposed corrections disrupt the implementation of the Joint Order.

After review of the proposed corrections and the representations of the parties, the following corrections to the Joint Order are approved:

- 1. **Page 1, Synopsis, lines 4-5**: Add the word "*deficiency*" to the end of the phrase "\$35,584,003 revenue requirement" contained in the Synopsis.
- 2. **Page 9**, **¶19**, **lines 1-2**: Change to read: "By this Settlement Stipulation, the Participating Parties request that the Commission approve an overall 5.77 per cent increase in natural gas rates, *which includes a \$4 million reduction* to the revenue requirement
- 3. **Page 9**, **¶19**, **line 4**: Change to read "to reduce the natural gas revenue requirement *deficiency* to \$35,584,003, *for a total revenue requirement of* \$652,480,437."
- 4. **Page 9,** ¶ **19, lines 7-8**: Change from: "An adjustment reducing net operating income by \$6,622,815 to \$64, 008,513" to "A number of adjustments, totaling \$6,622,815, reducing net operating income to \$64,008,513."
- 5. **Page 9, ¶ 21, line 6**: Change witness reference from "Karzmar, Parvinen, Lott" to "Karzmar, Parvinen, *Lazar*."
- 6. **Page 10**, ¶ **24 and Page 11**, ¶**30**: Change the phrase "to reduce its gas rates by \$0.28 per therm" to "*a gas cost reduction of approximately* \$0.55 *per therm*."
