- (1.) Recommend changing the word "secondary" in the first sentence to "incidental". Recommend changing the beginning of second sentence to "Examples include <u>but are not limited to ...</u>"
- (11.) Recommend the following change to the first sentence. "... or by another individual designated by the customer ..."
- (20.) Recommend the following change "... in a way that is different from the original written Estimate."

WAC 480-15-480 - Annual reports and regulatory fees. Concur as drafted.

WAC 480-15-490 - Tariff and rates, general. Concur as drafted.

WAC 480-15-500 - Tariff maintenance and fees. Concur as drafted.

WAC 480-15-510 – Changing commission-published tariffs. Concur as drafted.

WAC 480-15-520 - Individual carrier tariffs. Concur as drafted.

WAC 480-15-530 – Public liability and property damage insurance. Concur as drafted.

WAC 480-15-550 – Cargo insurance. Recommending adding "(5) Requiring the insurance provider to notify the WUTC of changes to coverage."

WAC 480-15-560 - Equipment safety requirements. Concur as drafted.

WAC 480-15-570 – Driver safety requirements. Recommend this rule mirror the federal safety requirements.

WAC 480-15-590 - Leasing vehicles. Concur as drafted.

WAC 480-15-600 – Lease responsibilities. Concur as drafted.

WAC 480-15-610 - Advertising. Concur as drafted.

WAC 480-15-630 - Estimates.

(2.) Recommend the following change – "... amount the carrier will charge to move ..."

(3.) Recommend adding – "...estimate prior to additional work being performed."

WAC 480-15-660 – Supplemental estimates. Concur as drafted.

WAC 480-15-710 - Bill of lading. Concur as drafted.

WAC 480-15-750 – Weight. Concur as drafted.

WAC 480-15-800 – Customer complaints and claims. Recommend reducing the time limit to file a claim for loss or damage to 6-months.

WAC 480-15-810 – Resolving customer complaints or claims. Paragraph 4a. – Recommend changing the time period to 90-days.

WAC 480-15-830 - Complaint and claims records retention. Concur as drafted.

WAC 480-15-890 - Commission-referred complaints.

- (1.) Change the "five days" to "ten days".
- (3.) Change the "120 day period" to "90 day period".

WAC 480-15-900 - Requirements for interstate operations. Delete paragraph (1c.)

The following are comments submitted by the Washington Movers Conference to proposed changes to WUTC Tariff No. 15-B contained in Docket TV-070466.

ITEM 05 – Application of Tariff. Concur as drafted.

ITEM 15 – Refusal to provide service, pickup shipment or deliver shipment. Concur as drafted.

ITEM 25 - Deliver to or from a warehouse. Concur as drafted.

ITEM 35 – Delivery time and means. Paragraph 2 – If the shipment is given to another carrier, under whose authority is the shipment moving?

ITEM 45 – Storage when delivery cannot be made. Concur as drafted.

ITEM XX – Disposition of unclaimed goods. The drafted language is too ambiguous. There are legal rules to consider when disposing pf unclaimed household goods.

ITEM 20 – Definitions.

Assessorial Services – In the first sentence, recommend changing the word "secondary" to "incidental". In the second sentence, add ...include <u>but not limited to</u>..."

Hourly-Rated Shipment – Recommend changing "35 miles" to "55 miles".

Mileage-Rated Shipment – Recommend changing the "35 miles" to "56" miles or more".

ITEM 55 – Other rates and charges. Recommend deleting the following Items:

- a. Household goods packing or unpacking.
- b. Boxes, cartons or other containers in which to pack household goods. These items cannot become "give away" items. The minimum/maximum rates are easily adjusted for inflation and the item list can be expanded to include new items including a section for rental pricing for the new plastic crates and wardrobe containers being introduced to the industry.
- c. Tape, paper or other products used to pack, unpack or move household goods. Charges for theses items are contained in the Packing Charges, ITEM 195.

ITEM 65 – Customer-packed goods. Concur as drafted.

ITEM 80 – Method of payment. Concur as drafted.

ITEM 85 - Estimates. Concur as drafted.

ITEM 90 – Carrier liability for household goods and customer valuation options.

5(b) – Depreciated value protection – Delete, no longer used.

5(d) - Replacement cost coverage - Recommend increasing the maximum carrier liability from "\$3.50" to "\$5.00"

ITEM 10 – Customer liability and responsibility. Concur as drafted.

ITEM XX – Items not accepted. Concur as drafted.

ITEM 95 - Bill of lading.

1.I - Recommend deleting Depreciated value protection.

ITEM 100 – Storage.

3.B – Charges for S-I-T and warehouse handling. Recommend changing "charges must be listed by the carrier and agreed to by the customer on the written estimate" to "<u>charges in accordance with the Tariff must be shown on the written estimate</u>". As previously stated in this ITEM, a move that includes S-I-T is one continuous move from origin to S-I-T to the final destination. Tariff rates must apply to the entire move.

ITEM 110 – Storage in vehicle. Concur as drafted.

ITEM 105 – General application of rates for mileage for mileage-rated moves.

1. Recommend changing "more than 35 miles" to "56 miles or more".

ITEM 205 – General application of rates for hourly-rated moves.

1. Recommend changing "moves of 35 miles or less" to "moves of 55 miles or less".

ITEM 115 – Weight of shipment. Concur as drafted.

ITEM 180 – Reweighing. Concur as drafted.

ITEM 50 – Overtime. Concur as drafted.

ITEM 200 - Mileage rates. Concur as drafted.

ITEM 201 - Mileage rates for shipments moving into storage-in-transit

1. Recommend changing "within 35 miles" to "within 55 miles".

ITEM 230 - Hourly rates. Concur as drafted.
