ORDER DENYING RECONSIDERATION

I. <u>DIRECTOR'S CONSIDERATION</u>

- 1.1 <u>Review</u>. Respondent Kevin Williams filed a Petition for Reconsideration on June 13, 2011 requesting vacation of the default under the Findings of Fact, Conclusions of Law and Final Order of Default entered on May 25, 2011 and served on June 3, 2011 (Final Order).
- 1.2 <u>Record of Proceeding</u>. The entire record of this proceeding was presented to the Director for her review and the entry of a final decision.
- 1.3 <u>Issue for Reconsideration</u>. The Statement of Charges in this matter was served on the Respondent at 15202 149th Ave SE, Renton, WA 98058-8172. Mr. Williams claims that "[s]everal months ago I notified the limousine division of the DOL of [a] mailing address change" from 15202 149th Ave SE, Renton, WA 98058 to his home address of 15810 74th Ave NE, Kenmore, WA 98028.

On June 16, 2011, a Request for Response was issued to the Limousine Carrier Program (Program). The Program responded on June 22, 2011, with a declaration from Harumi T. Tolbert, Regulatory Program Manager, stating that, according to Department of Licensing and Master License Service records, the Statement of Charges was served on the Respondent's address of
