Hello - I see the comment window for the PSE DR RFP closes today. Is this comment window for vendors? Or is it really intended for Ratepayers or Stakeholders impacting by a filing.

I am a vendor. For your reference, the comments/questions I would like to raise are:

1) **Term of the Contract** - Is the Contract Term for the DR RFP limited to 5 years. This is all that is provided in the Pricing Appendix If this is the maximum Contract Term, would

PSE consider extending the Contract Term to 10 years? This will allow vendors to amortize equipment over a longer period of time and should lead to lower prices and better value for ratepayers.

- 2) **Likelihood of Award** PSE did not award anything as part of the 2016 DR RFP. And to my knowledge they did not award anything from the 2018 All-Source RFP. Does PSE expect to award anything based on this 2020 RFP?
- 3) **Avoided Cos**t Could PSE provide a worked example of how they will use the figures in the DR RFP, Page 37 Exhibit A , Table 2 (2017 IRP Forecast of Avoided Costs) to evaluate the cost effectiveness of the DR bids?
- 4) **Program Support** Does PSE have the necessary team, programs and price incentives (like Peak Time Rebates) in place to allow PSE to onboard and scale a cost effective and robust portfolio of DR resources?
- 5) **CETA Applicability and Timing** Will the **CETA** provisions be considered in the evaluation of the cost effectiveness of the DR bids. I understand there are DR minimums, Emission targets, Equity targets and other non-price benefits that could be coming into play here.

Please advise if you consider these comments submitted or if I should submit by some other channel.
