
Description of amendment:

The Agreement is amended to provide specific terms and conditions under which CLEC exchanges traffic with CenturyLink as set forth in Attachment 1 to this Amendment.

The amendment amends the interconnection agreement first approved by the Commission on February 9, 2022 in WUTC Docket No. UT-210906.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
