RATE INCREASE NOTICE FOR COMMERCIAL CONTAINER AND CAN SERVICES

Dear Customer:

November 30, 2022

Murrey's Disposal Co., Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (UTC). The last general rate increase was approved by the UTC January 1, 2019. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets.

If approved, the proposed rates below will become effective January 1, 2023. The rate per pick-up will increase as follows:
