4	JUDGE THOMPSON: Thanks, Ryan. Currently, I
5	see representatives for staff, public counsel, and the
6	company online, but I do not see any customers at this
7	time. So at this time, why don't we go ahead and wait a
8	few minutes and see if anybody joins us.
9	MELISSA CASTANEDA-KERSON: Sounds good.
10	JUDGE THOMPSON: And hello to the individual
11	who just joined us. It appears your name might be
12	Morgana. Are you here for the public comment hearing?
13	(No audible response)
14	JUDGE THOMPSON: And to the two individuals who
15	just joined us, names Morgana or Morgana and Satomi, are
16	you two here for the public comment hearing for
17	Washington Water Supply?
18	UNIDENTIFIED SPEAKER: Yes. I don't know that
19	I really have anything to say. If I hear something that
20	I want to respond to, I'll raise my hand.
21	JUDGE THOMPSON: Okay. Wonderful.
22	MELISSA CASTANEDA-KERSON: Sorry. Hi. My name
23	is Melissa Castaneda-Kerson, and I'm with public
24	involvement.
25	If either of you or anyone on the line would

1	like to speak, please go ahead and put your first and
2	your last name into the chat so we can get you signed in
3	for this meeting.
4	Of course, if you don't want to speak, you're
5	welcome, you know, to say you don't want to. But we
6	definitely would like to get you signed in to the
7	meeting.
8	JUDGE THOMPSON: Okay. And at this time, I'll
9	give it two more minutes, and then I'll go ahead and
LO	introduce the case. And we can see if anyone wants to
L1	speak at that time, if that's okay with everybody.
L2	MELISSA CASTANEDA-KERSON: Sounds good to me.
L3	JUDGE THOMPSON: Okay. I don't see anybody
L4	else joining us. So let's go ahead and get started.
L5	Melissa, did you have anything to add before I
L6	get started with the introduction?
L7	MELISSA CASTANEDA-KERSON: No. It looks like
L8	Morgana went ahead and put her first and last name in the
L9	chat.
20	And then Satomi, if you would like to speak, or
21	if you could put your first and last name into the chat
22	as well, that would be great so we can get you signed in.
23	And I will let you go ahead.
24	JUDGE THOMPSON: Okay. Thank you.
25	Good evening, everyone. Today is Tuesday,

1	February 18, 2025. And this is a public comment hearing
2	of the Washington Utilities and Transportation Commission
3	in Dockets UW-240079 and UW-230598, which involve
4	Washington Water Supply's general rate case and request
5	for a surcharge which is related to the well
6	rehabilitation on the Echo Glen well.
7	I am Connor Thompson, an administrative law
8	judge here at the commission. I am the presiding officer
9	assigned to this matter.
10	As in a court of law, I am not able to answer
11	questions or engage in a dialogue tonight, but I am here
12	to listen to your comments, which will become part of the
13	record in this case.
14	I appreciate you joining us for this public
15	comment hearing tonight. I will provide a brief overview
16	of the case and the process for this hearing, and then
17	turn it over to Melissa Castaneda-Kerson, public
18	involvement specialist for the commission, to provide
19	some logistics about the hearing and further instructions
20	for those who wish to speak.
21	We have a scheduled public comment hearing for
22	this proceeding. Anyone who wishes to speak will have an
23	opportunity to do so, but you're certainly not obligated
24	to do so.

A brief overview of the case: Washington Water

1	Supply filed with the commission a proposed surcharge on
2	January 22, 2024. The commission suspended that request
3	and ordered the company to file a general rate case while
4	consolidating the request with Docket UW-230598.
5	Subsequently, the commission filed a complaint
6	on May 30, 2024, against the company, alleging five
7	counts.
8	And on June 28, 2024, Washington Water Supply
9	filed documents seeking to amend rates in the form of a
10	surcharge or general rate request, and the commission set
11	this matter for adjudication on March 18, 2025.
12	Washington Water Supply's June 28, 2024, filing
13	requests a surcharge of \$3.18 over 15 years or until
14	costs related to rehabilitation are recovered, or
15	customers may opt into a one-time payment of \$571.43.
16	Washington Water Supply requests these
17	increases due to increased expenses incurred from
18	rehabilitating the Echo Glen well.
19	Washington Water Supply's last general rate
20	increase became effective on January 1, 2001.
21	The following parties are participating in this
22	proceeding: Washington Water Supply, Incorporated;
23	Commission staff: The commission staff looks
24	to ensure rates are fair, just, and reasonable and in the
25	public interest, and participate like any other party to

1 the proceeding; 2 And the Public Counsel Unit of the Attorney 3 General's Office, representing residential and small 4 commercial customers. Following the hearing in this matter, the 5 Commission will enter an order based on the record, 6 7 including all public comments and testimony from this 8 public hearing. 9 In addition to the testimony, evidence, and 10 comments made tonight, we invite customers and members of 11 the public to share their views in this matter pending 12 before the Commission. 13 The comments we receive from you this evening 14 will be made part of the formal record in this case. 15 that reason, we are recording tonight's hearing, and I am 16 here tonight to listen to your comments. 17 By statute, the Office of Public Counsel 18 represents the interests of Washington Water Supply's 19 residential and small commercial customers. 20 And I see that Robert Sykes, representing 21 public counsel, is attending the meeting this evening. 22 If you have questions about this case, you can 23 contact the commission's public involvement staff,

Melissa Castaneda-Kerson, who is assigned to this case.

20	Castaneda-Kerson, from our public counsel our public
21	information staff, to go over the logistics for this
22	meeting. Melissa?
23	MELISSA CASTANEDA-KERSON: Thank you.
24	Good evening. My name is Melissa
25	Castaneda-Kerson, and I'm a public involvement

2	Commission. I will be the moderator for the comment
3	hearing this evening.
4	If you did not sign up in advance to provide a
5	comment at this evening's hearing and you wish to do so,
6	please go ahead and put your first and last name into the

25	hearing, be the date for submitting comments, the

1	deadline for submitting comments?
2	ATTORNEY SYKES: Uh, yes. That is what we
3	would request.
4	JUDGE THOMPSON: Okay. I believe that should
5	work for everybody.
6	ATTORNEY SYKES: Your Honor, as far as the
7	public comment exhibit, can we have an extra week after
8	the deadline to put that together?
9	JUDGE THOMPSON: March 25, 2025?
LO	ATTORNEY SYKES: Yep.
L1	JUDGE THOMPSON: Okay. That works as well.
L2	And we will go ahead and probably reiterate that at the
L3	hearing as we typically do.
L4	But let's go ahead and plan on March 18 being
L5	the deadline for submitting comments and March 25 for
L6	submission of the exhibit.
L7	Okay. At this time, I will make one last call.
L8	Is there anyone else interested in making comments
L9	tonight?
20	Okay. Hearing nothing, and unless anybody
21	disagrees, I'm prepared to adjourn the meeting.
22	And hearing nothing, I want to thank everyone
23	for appearing tonight. And thank you for your time. I
24	hope you all have a good rest of your evening and a good
25	rest of your week.

1	This concludes the public comment hearing in
2	this case, and we are adjourned.
