1. Pursuant to WAC 480-07-835 and WAC 480-07-875, the Northwest Industrial Gas Users (“NWIGU”) respectfully move the Commission for clarification of Order 08, dated May 7, 2012 (“Order”). The purpose of this motion is to correct an obvious and ministerial error in the Order and this motion does not seek to change the outcome with respect to any issue in the Order.

2. Paragraph 346 of the Order refers to the Multiparty Settlement Re: Natural Gas Rate Spread and Natural Gas Rate Design (“Gas Settlement”). In listing the parties to the Gas Settlement, the Order incorrectly identifies ICNU instead of NWIGU as one of the “Settling Parties-Gas.” Although ICNU was a party to a similar settlement agreement involving electric rate spread and rate design, it was not a party to the Gas Settlement. The final exhibit list in this matter identifies the Gas Settlement as Exhibit No. SPG-2 and confirms that NWIGU is a party to that settlement. Further, Exhibit No. SPG-1T contains the joint testimony supporting the Gas Settlement, sponsored in part by Donald Schoenbeck on behalf of NWIGU.

3. Based on the foregoing, NWIGU requests the Commission to correct this obvious and ministerial error and to replace the reference to “ICNU” in Paragraph 346 of the Order with “NWIGU.”


