Dear Mr. King:

i-wireless, LLC hereby provides notice of changes to its Lifeline offering in accordance with changes in the Federal Communications Commission's minimum service standards set forth at 47 C.F.R. § 54.408 effective December 1, 2017.

As summarized in Attachment A attached hereto, effective December 1, 2017 i-wireless' non-tribal Lifeline customers will receive 750 voice minutes, unlimited text messages, and 500 megabytes (MB) of data at a net cost of \$0.00 per month. Beginning February 1, 2018, this plan will only be available to existing "Legacy" customers, and non-tribal customers enrolling February 1, 2018 and after will have the choice of a voice plan with 750 voice minutes, unlimited text messages, and 50 MB data, or a broadband plan with 250 voice minutes, unlimited text messages, and 1 gigabyte (GB) of data. The Tribal plan will now include 2 GB of data.
