**RE: Docket UE-240004 (Advice No. 2024-03)
 Puget Sound Energy’s Electric Tariff Revision – Do Not Redocket**

Dear Executive Director Killip:

In accordance with WAC 480-80-111, Puget Sound Energy (“PSE” or “the Company”) hereby submits in connection with Docket UE-240004 the following revised electric tariff sheet as a substitution for the pending tariff sheet that accompanied its February 15, 2024 filing, submitted under Advice No. 2024-03.

The purpose of this substitute tariff filing is to replace the pending 12th Revision of Schedule 52, Sheet 52-B, with the 13th Revision, in accordance with the Multiparty Settlement Stipulation and Agreement and Order 02 in Docket UE-240087. With this filing, there is no material change to the terms or conditions of service contained in the pending tariff sheet. The changes are typographical corrections only.

By way of background, on December 27, 2022, PSE submitted a compliance filing in Docket UE-220066 following issuance of Orders 24/10. This filing contained the 12th Revision of Sheet 52-B of electric Schedule 52, amongst other tariff sheets for other electric schedules. This filing was rejected in part in Order 26/12 in Docket UE-220066, for reasons unrelated to the 12th Revision of Sheet 52-B. On January 9, 2023, PSE submitted an updated compliance filing in Docket UE-220066. This filing inadvertently did not contain the 12th Revision of Sheet 52-B of electric Schedule 52. The January 9, 2023 filing was approved, and rates became effective on January 11, 2023.

In January 2024, PSE contacted Commission Staff to explain that it had identified that the 12th Revision of Sheet 52-B of electric Schedule 52 was inadvertently omitted from the January 9, 2023 compliance filing. On March 5, 2024, Staff began an investigation into the Company’s

compliance with RCW 80.28 and WAC 480-100 in Docket UE-240087. On April 19, 2024, a Joint Settlement Agreement and supporting Testimony were filed in that docket. On August 28, 2024, the Commission issued the Initial Order approving the settlement.

On September 6, 2024, PSE submitted its supplemental compliance filing in Docket UE-220066, as authorized by Order 02 in Docket UE-240087. Commission Staff reviewed PSE's compliance filing and issued a compliance letter on September 19, 2024, stating that it believes that the revised tariff sheet complies with Order 24/10 in Docket UE-220066, entered December 22, 2022, and Order 02 in Docket UE-240087, entered August 28, 2024. On September 24, 2024, the Commission filed a letter affirming Staff's finding. The tariff sheet filed by PSE became effective on September 14, 2024. The typographical corrections to the pending version of Schedule 52, Sheet 52-B, correct the version number.

The tariff sheet described herein reflects the original issue date of February 15, 2024, and the original effective date of March 16, 2024. Posting of proposed tariff changes, as required by WAC 480-100-193, is being accomplished by posting the proposed tariff sheets on the PSE web site coincident with the date of this transmittal letter.
