On June 16, 2011, the Washington Utilities and Transportation Commission granted YourTel America ETC status in the State of Washington via an Order effective that day. It included language that YourTel is to abide by the following:

YourTel shall file with the Commission any future changes to its rates, terms, or conditions at least one day prior to the effective date of the change.

YourTel America hereby places on file the following revisions to their data upgrade section, to their additional minutes section, and to their service activation fees for data plans. All revisions are applicable to both lifeline and non-lifeline subscribers. Existing plans will remain unchanged.

All data plans (Lifeline and non-Lifeline) will incur a one-time $\$ 49.95$ premium plus activation fee or a $\$ 19.95$ standard plus activation fee dependent upon phone and plan selected.
