Re: Letter on Annual Report Filing and G-124

Dear Ms. Washburn:

We are in receipt of a letter dated June 9, 2003, referencing our company's failure to file an Annual Report for G-124 for 2002. As your records will reflect, the bulk of the authority under Certificate G-124 was impacted by the decision by the City of Seattle to assume jurisdiction over commercial solid waste on or about April 1, 2002. Previous correspondence from Rabanco has addressed this issue with the staff, and we are aware that the City of Seattle and has also separately notified you of this event. Thus, while we are willing to relinquish the Certificate under these circumstances, pursuant to WAC 480-70-141(5)(a), we would presume that the Certificate would be subject to reinstatement should the City of Seattle and/or the City of Bremerton opt to cease jurisdiction over solid waste with the authority to regulate solid waste in Seattle and/or Bremerton reverting to the Commission under RCW 81.77.0201 et seq. In any event, we raise this issue with the Commission in order to notify it of our intent in the future to assert reversion rights over G-124 should circumstances ever warrant.

GARBAGE COLLECTION SERVICE In Seattle (using as a boundary the corporate limits as of September 6, 1960); in Bremerton (using as a boundary the corporate limits as of September 6, 1960) and in that portion of Kitsap County located west of Bremerton described as follows: Rocky Point, Marine Drive and Madrona Point. In Seattle and King County limited to hauling presently authorized for the United States Army and the United States Navy.

REFUSE COLLECTION SERVICE Consisting of lamp black, acid, sludge, broken fire bricks, building and fire refuse and non-commercial sawdust from points in the Cities of Seattle and Bremerton to points in King and Kitsap Counties. Demolition debris, rubble and brush (excluding putrescible garbage, refuse and dirt) from demolition project site locations, restricted to semi-trailer equipment of 35 cubic yard or more capacity and restricted against the use of drop-off boxes or detachable boxes or containers and further restricted against the transportation of garbage and/or refuse from residential or commercial establishments in the State of Washington.

Sewage and/or dewatered Sludge and Sewage Sludge in the State of Washington under contract with the MUNICIPALITY OF METROPOLITAN SEATTLE.

The following authority was obtained by transfer of Certificate No. G-137, standing in the name of Donald J. Kreger, d/b/a Mighty-Mite Rubbish Removal Co.

RUBBISH AND DEBRIS COLLECTION SERVICE not requiring the use of mechanical loading equipment at origin or destination in that portion of the City of Seattle described as follows: Bounded on the south by Union Bay, Portage Bay, Lake Union, Lake Washington Ship Canal and Salmon Bay Waterway; on the west by the shoreline of Puget Sound; on the north by 145th Street; and on the east by the shoreline of Lake Washington.
