This e-mail confirms my voice mail of earlier today regarding regulation of Ryther Child Center as a non-profit bus company under WAC Chapter 480-31.

Staff has determined that Ryther Child Center is not regulated under statute and rules because it does not receive compensation or funding for the express purpose of providing transportation services. While Ryther Child Center does receive compensation or funding, it is for the purpose of providing services to children, and the transportation services it provides is incidental to its other, non-transportation service.
